## Introduction

CONVEY BROS Ltd are committed to a policy of protecting the personal information of individuals, our staff and customers or potential customers in accordance with The General Data Protection Regulation (GDPR).

Ensuring the privacy of your personal information is very important to us. Our Privacy Policy outlines the information we collect about you, how we use the information, disclose and otherwise manage and keep this information secure.

This Privacy Policy applies to information received through our web-site, e-mail, telephone and mail. Our policy also identifies how to access and amend any of your personal data that we hold and the choices you have to restrict our usage of this information. Aside from helping us deliver our service, the information you share with us means you'll receive a more personalised and quality service.

## What information do we collect

## **What legal basis do we have for processing your personal data**

Our processing of your personal information is necessary:

- for the performance of **contracts** to which you will be a party to and in order to take steps at your request prior to you entering into those contracts;
- for the purposes of **legitimate interests** pursued by us;
- in order to comply with a **legal obligation** to which we are subject.

In relation to any processing of special categories of personal information such as information about your health, we will generally rely on obtaining specific consent from you at the time unless there is otherwise a legal requirement for us to process such information.

### *Legitimate interests*

Where our processing is based on the legitimate interest grounds described above, those legitimate interests are: (i) collecting personal information to provide you with a smooth and efficient customer experience; (ii) running our business; (iii) to provide the products and services you have requested; (iv) to prevent fraud; and (v) for our own marketing, research and product development.

## **When do we share personal data**

We will treat personal data confidentially. As expressly set out in this policy we will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so.

However, we share your information with the following categories of companies as an essential part of being able to provide our products and services to you, as set out in this Privacy Policy:

- Companies that help us fulfil your contract such as hire companies
- MEWP suppliers
- Scaffold suppliers
- Sub-contactors

We may also share your personal information with:

- law enforcement agencies, other governmental agencies or third parties if we are required by law to do so;

### **Data security**

Your privacy is important to us. We maintain reasonable administrative, technical and physical safeguards in an effort to protect against the loss, theft, unauthorised access, use, modification and disclosure of personal information in our custody and control. We have implemented measures in an effort to safeguard the personal information in our custody and control, including only providing access to personal information to employees who require such information.

### **How do we secure personal data?**

We are committed to ensure data and personal data is secure. We use an internal peer to peer network for business data which is never exposed to the internet, however all computers still have internet security, anti-virus, firewall and malware protection. Both our database and payroll software which includes personal files are backup to a fireproof server daily and also to two portable Military grade flash devices that safeguard 100 percent of confidential data with 256-bit AES hardware-based encryption which are removed from our head office every day.

### **How long do we keep your personal data for**

#### **Personal data is maintained for specific periods;**

Applicable employment and legal requirements: as required by law.

Contractual obligations: One year from end of contract.

Recruitment information: One year from interview date.

Employee personal information: One year from leaving date.

Paper documentation is shredded at the disposal date.

Electronic data is deleted at the disposal date.

### **Your rights in relation to personal data**

Convey Bros Ltd complies with the GDPR and as such every ‘data subject’ has the following rights;

At any time, you have the right:

- to request access to or a copy of any information which we hold about you

Any request for access to or a copy of your information must be in writing and we will endeavour to respond within a reasonable period and in any event within one month in compliance with data protection legislation. We will comply with our legal obligations as regards your rights as a data subject.
